Important Form 1099 Reminder

You may be required to issue 1099's if you operated a business or owned rental property and you paid a total of \$600.00 or more during the calendar year to an individual, trust, partnership, LLC or another business form (corporations are the only exempt business form) for services rendered or rent, you must issue that person a 1099 Form. 1099s are due to both the recipient and IRS by January 31.

You will find a 1099 information sheet on the back of this page. If you have 1099's that need to be issued and would like to retain our firm to prepare the required forms, please see that all of the information is completed and sent to our address above or faxed to (310) 410-7241. Feel free to make copies of the 1099 Information Sheet if you are required to issue more than one 1099. Be sure to provide us with the completed information sheet for each 1099 you are required to issue by January 15 so that we may file the required forms in a timely fashion. Alternatively, you can use a 1099 filing service such as 1099online.com.

Filing 1099s are very important as severe penalties can be assessed for failure to file required 1099's or for late filing of the forms.

Note: This form is not intended to replace IRS Form W-9 which should be completed by the recipient of the funds prior to receiving any form of payment. Use this form to provide information to us for preparation of the 1099 form. Form W-9 along with this form is available from our website www.BowersTax.com.
